Dear Prospective ECD LEVEL 4 Student,

Thank you for enquiring about our accredited training.

What follows is a basic breakdown of how the EduExperts ECD L4 training works.

ECD Level 4 - SAQA ID 58761, is an ETDP SETA and SAQA accredited training course for prospective Pre-School Teachers, Day Mothers and Teaching Assistants, to children aged 0 to 3 years. This is the accepted first step towards attaining a comprehensive ECD qualification. A period of approximately 13 months is sufficient to complete the 14 modules – Unit Standards – consisting of 3 components:

1. A compulsory Online contact training session monthly – (A second support session is optional)
2. Practical contact sessions with preschool learners are required including evidence of these contact sessions.
3. Theory and assignments to be assessed in determining competency.

You will be required to upload all completed theoretical and practical assignments in adherence to submission dates which will be strictly monitored by your Facilitator and Assessor – A one month period will be provided to complete and upload assignments of the facilitated and presented Module.

Adhering to the programme, compiling a complete e-Portfolio of Evidence (e-POE) will be required at the end of the course for Final external Assessment, Moderation and ETDP SETA Verification. When confirmed competent you will receive the following:

- A completion certificate from EduExperts.
- A Statement of Results from ETDP SETA - (SOR)
- A SAQA accredited and sealed certificate to be handed to you during a formal Graduation Ceremony, the date of this ceremony will be communicated well in advance including date, time and venue. The SAQA certificate will enable you to register partially with SACE (South African Council for Educators) as a certified Early Childhood Development Practitioner.
- Your L4 Certificate through EduExperts will afford you 285 Credits, these CAT credits above 140 Credits will be accumulated to shorten the training period of L5,6 and 7.

Answers to Frequently Asked Questions:

1. The minimum age for enrolling for ECD L4 is 18
2. A mandatory online Comprehension Test will determine your English competency. Success in this Comprehension Test will affirm your acceptance into the ECD L4 training
3. The SAQA certificate will give you an ECD qualification equivalent to an NQF level 4 Matric
4. Foreigners from SADEC Countries will need a copy of their Passport and latest qualification to be admitted

Important student financial information:

1. Registration Fees are NOT REFUNDABLE
2. EduExperts is registered with Fundi for student loans, all relevant documentation can be requested at office.eduexperts@gmail.com.
3. Should you fail to complete your required credits within 13 months or should your account not be paid up in full at the end of the 13 months, you will be charged an additional admin fee of R1800.
4. In the unfortunate event that you wish to give notice, it must be done in writing and mailed to ptid@mweb.co.za or finance@eduexperts.co.za
5. In the event of cancellation, a single term (3 months) tuition fee will be payable to EduExperts. Total: R2,700.00 for L4 and R3 720 for L5. Notice letters are to be sent to ptid@mweb.co.za or finance@eduexperts.co.za .
6. With final submissions all accounts have to be paid in full before your Portfolio of Evidence will be submitted for Verification to the ETDP SETA.
7. EduExperts has the full legal right to withhold all certificates, if there are any outstanding fees on your account until the account has been settled in full.
